## **Environmental, Health, Safety and Sustainability Policy**

- Provide EHS training and information to its employees to enable them to perform their duties safely.
- Involve and engage employees through participation and consultation in the development and improvement of the EHS management system.
- The environmental management system and health and safety management system are continuously updated to improve EHS performance.
- Consider Environmental, Health and Safety aspects and effects when developing new products or processes.
- The choice of production materials and the implementation of production processes should strive for the
  efficient use of raw materials, the efficient use of natural resources, and where possible, reusable, or
  recyclable materials.
- Open up to society and other interested parties regarding Environmental, Health and Safety considerations.
- When conducting business, strive to prevent pollution in all facets of the business.
- Preventing personal injury, property and environmental damage and striving for continuous improvement in the field of EHS.

Our employees are continuously made aware of the importance of KION's safety management systems. Stakeholders will be involved where necessary and appropriate in efforts to improve environmental performance.
